

2007 SOUTHEAST SECTION ANNUAL DIRECTORS MEETING – 16 June 2007

The Southeast Directors met at 4:40 PM on Saturday, 16 June 2007 after the Animal Round at the 2007 Southeast Field Championship at Durham County Wildlife Club.

1. Diane Watson was introduced as the new Southeast Section Pro Rep. She ran unopposed for the office.
2. Re-election of Tim Austin for another term as SE Councilman previously reported after Las Vegas Meeting.
3. We discussed the contract that is to be signed to possibly sell the NFAA property in California and options for moving NFAA Headquarters. We also discussed the options for the 2008 Stan Classic.
4. No motions were made concerning our meetings. Our Annual Southeast Sectional Directors Meeting will be at the Southeast Field in 2008 and additional head to head meeting will be held in Las Vegas.
5. The directors desired that the 3-D Format for the Sectional Tournament be left for to the bid process.
6. KY moved to have multiple Indoor sites. NC seconded. GA voted No. TN, KY, NC, SC, FL voted yes. We will have multiple Indoor sites in 2008.
7. NC moved to table Indoor Bid Selection pending discussion with various state memberships until August. GA seconded. FL and KY vote No. TN, SC, GA, NC vote yes. Indoor site selection is tabled until August. At that time Directors will need to address: (A) How many sites, (B) Whether multiple sites will be allowed in a state, (C) Whether multiple scores, Mulligans, will be allowed, and (D) Submit bids for hosting, including dates.

8. FL moved for the Sectional Indoor to have two NFAA Indoor Rounds with the tie breaker the total inside out "x" count. All scores will keep both a normal "x" count and an inside out "x" count. NC seconded. KY votes No. FL, TN, NC, GA, SC vote yes. Motion carries.
9. FL places a bid for consideration in August to host one of the Southeast Indoor sites in Tallahassee (Tri-State Archers) on 8-9 March 2008. KY places a bid for consideration in August to host one of the Southeast Indoor sites in Shepherdsville KY (Chickasaw Archery Club) on 8-9 March 2008. Both bids to be considered in August.
10. FL moved to have two sites for the 2008 Southeast Sectional Field. Motion died for lack of a second.
11. 2008 Southeast Sectional Field: Bids received from Gainesville FL (Gator Bowmen) and Clemson SC (Keowee Bowmen). Votes for Gator = FL, NC. Votes for Keowee = SC, GA, KY, TN. – 2008 SE Field will be at Keowee Bowmen in Clemson SC on 21 and 22 June 2008.
12. 2008 Southeast Sectional 3-D: Bids received from Ft Meade FL (Central Florida Bowhunters) and Myrtle Beach SC (Sandune Archery Club). Votes for C Fla BH = FL. Votes for Sandune = SC, GA, NC, KY. TN abstained. – 2008 SE 3-D will be at Sandune Archery Club in Myrtle Beach SC on 12-13 April 2008. The course will be three 20 target 3-D rounds, all marked distance: the club's targets have both center and offset 12's and the club will announce which will be used on what rounds when it supplies detailed shoot information.
