### Second Reading Items

Lee County hosting the 2025 NAFAC wants a two day – 28 Field, 14 Animal and 28 Hunter on the second weekend of December. Passed

International to be shot with two rounds shot on one day Saturday or Sunday. Passed

split the 900 and Classic 600 into two separate shoots held on the same weekend at the same location. 900 on Saturday and Classic 600 on Sunday. Program Coordinator moves that we offer the 900 on Saturday or Sunday and shoot the Classic 600 two weeks later also offered for Saturday or Sunday. Seconded by Exec VP. Yes – Program Coord, Central VP, Exec VP – No: NFAA, Sec/Treas. Passed

Moved to accept East River's bid to host a site for the NFAA Indoor on March 22-23. They are aware that we are hosting earlier dates but that they are the only host in March. For multiple shooting an archers first score in an age bracket and style counts. Archers may shoot a different class (For example: Freestyle could shoot Bowhunter Freestyle (just remove the magnification), Barebow Recurve could shoot Barebow Compound and Olympic Freestyle could shoot Limited Freestyle for the second round (there is no requirement for a compound bow for Limited Freestyle or Barebow Compound) or age bracket (for archers over 50). All awards will be given out after the last shooting time at East River. Passed

Shooter of the Year. There has been a request to offer other choices for the shooter of the year award and what is given out is explicitly listed in the rulebook. Archers to be given their choice of three options. Rain Jacket, Belt Buckel or the Polo with the Plaque. Other choices can be offered or asked for (Duffle?). Passed.

#### **New Business**

Matt Hall offered the indoor range where he works for the FAA 18M. Sec/Treas moved that we offer Matt Hall a site for the 18m shoot. Second by Central. So voted. We will have
